A VEHICLE PARKED WITHOUT A VALID CELEBRATION PARKING DECAL OR TEMPORARY PARKING PERMIT IN LAKESIDE PARK IS SUBJECT TO TOWING AT THE OWNER'S EXPENSE. THE PARKING DECAL MUST BE DISPLAYED IN THE PROPER LOCATION PER TYPE OF VEHICLE. TEMPORARY PARKING PERMITS MUST BE HUNG FROM THE REAR VIEW MIRROR AND VISIBLE FROM OUTSIDE THE VEHICLE. PROPER PLACEMENT OF CELEBRATION RESIDENT PARKING DECAL

CAR / TRUCK

PLACE THE DECAL ON THE LEFT SIDE (DRIVER'S SIDE) OF THE REAR WINDOW.
WHEN THE REAR WINDOW IS DARK TINTED, PLACE THE DECAL ON THE LEFT SIDE
OF THE FRONT WINDOW (DRIVER'S SIDE) IN THE LOWER CORNER.

NEV

PLACE THE DECAL ON THE RIGHT SIDE OF THE FRONT WINDOW.

MOTORCYCLE/SCOOTER

PLACE THE DECAL ON THE FRONT GLASS OR REAR SPOILER IN A VISIBLE LOCATION.

HANG TAG

HANG THE TAG FROM THE REAR VIEW MIRROR SO AS TO BE VISIBLE FROM OUTSIDE THE VEHICLE.

COMMERCIAL VEHICLES ARE PROHIBITED EXCEPT WITH PRIOR WRITTEN PERMISSION FROM TOWN HALL. ROUTINE VEHICULAR REPAIR OR MAINTENANCE MAY NOT BE PERFORMED IN THE COMMON AREAS. A VEHICLE PARKED WITHOUT A VALID CELEBRATION PARKING DECAL OR TEMPORARY PARKING PERMIT IN LAKESIDE PARK IS SUBJECT TO TOWING AT THE OWNER'S EXPENSE. THE PARKING DECAL MUST BE DISPLAYED IN THE PROPER POSITION PER VEHICLE TYPE. TEMPORARY PARKING PERMITS MUST BE HUNG FROM THE REAR VIEW MIRROR AND VISIBLE FROM OUTSIDE THE VEHICLE. CELEBRATION RESIDENTIAL OWNERS ASSOCIATION, INC. [CROA], IS NOT RESPONSIBLE FOR ANY DAMAGE TO ANY VEHICLE OR LOSS OF PROPERTY FROM A VEHICLE PARKED IN THE CROA COMMON AREAS.
